

### Second Call for Papers

The North American Chapter of the World Sturgeon Conservation Society still has some slots left in the contributed papers session of its 3<sup>rd</sup> annual meeting to be held September 1-2, 2010 at Chico Hot Springs

Resort (<u>www.chicohotsprings.com/</u>) near Livingston, Montana. *Get your abstracts in by April 30, 2010 (details on page 2).* We will also be conducting two pre-conference handson workshops on 1) sturgeon conservation genetics, and 2) sturgeon age estimation and tagging techniques held at the Bozeman Fish Technology Center August 31.

Sturgeon and paddlefish species worldwide are threatened due to overfishing, habitat loss, and pollution. Efforts to manage, preserve, and restore these species have increased substantially in the last 30 years, especially in North America where some of the best populations still remain, and where some of the longest running proactive restoration programs exist. These research, management, and restoration programs will be the focus of papers presented and workshops conducted in Montana in late August-early September this year at our annual WSCS NAC meeting.



# We encourage sturgeon and paddlefish researchers, biologists, managers, and private sector interests to submit your abstracts.

Abstract Submission: *Please submit your abstract* (maximum 250 words) by *April 30, 2010* to Molly Webb at Molly\_Webb@fws.gov. Abstracts should include a statement of objectives, a brief description of methods, principal results, and conclusions or management recommendations. Include scientific names in the abstract, but not in the title. The title should clearly describe what you will present. Please do not abbreviate place names (e.g. state or country) in the title. Include presenting-author name, and names of co-authors, with affiliations. Due to unique (but incredibly scenic) room lay-outs at Chico Resort, we will not be able to display posters at this year's meeting.

### Workshop and Conference Registration:

**Workshops:** Workshops will be held on August 31 at the Bozeman Fish Technology Center. Space in workshops will be limited and filled on a first come first serve basis.
